

Dr. John Gershenson is the Director of the <u>Humanitarian Engineering and Social Entrepreneurship (HESE) Program</u> at Penn State University. He has a B.A. in physics from Cornell University, an M.S. in mechanical engineering from The Ohio State University, and a Ph.D. in mechanical engineering from University of Idaho. His research—which includes work on product/process architecture, lean/sustainable design and manufacturing, and appropriate technologies—includes more than 75 peer-reviewed publications and he has been principal investigator or co-principal investigator on proposals valued at more than \$10 million.

He has strong experience in developing technologies and their applications in Kenya, including as CEO of a startup. Dr. Gershenson's research lab is currently developing 3D printing of medical technologies for use in rural healthcare clinics, particularly in East Africa. The HESE program is also very active in medtech, agtech, and edtech.

Decolonizing Technology and Emotional Well-being: Inclusive Design for Healing and Liberation

MindHeart aims to address these disparities by designing tools that prioritize emotional and spiritual health through inclusive practices rooted in empathy, accessibility, and the values of interconnectedness.In this presentation, we will introduce MindHeart AI, the world's first technology company for spiritual health, and our approach to liberatory technology for spiritual health and emotional well-being. Al Startups in Africa: Leap Frogging Voids with Smart Solutions

Africa's innovation landscape positions AI startups as key drivers of transformation, using smart technologies to tackle systemic gaps and reshape development. This panel will explore how African entrepreneurs can scale AI to address infrastructure, services, and institutional challenges, often worsened by limited resources. By focusing on context-driven solutions, these startups will show how collaboration, intra-African partnerships, and South-South knowledge exchange can accelerate scalable, adaptive technologies.

Drawing on insights from the AI for Africa Thinktank, the discussion will highlight how AI ventures can turn institutional gaps into opportunities, from improving agricultural value chains to expanding healthcare access. By leveraging assets like mobile tech and local talent, startups can create agile solutions that overcome infrastructure limitations.

The panel will also discuss fostering resilient innovation ecosystems through cross-border collaboration, ethical AI governance, and investor-community alignment, emphasizing how Africa's AI startups can lead in equitable, advanced technological innovation.

Designing the Future: Leveraging Technology for 1.5°C Lifestyles

This workshop addresses the urgent need for transformative shifts in lifestyles, particularly in the Global North, to limit global warming to 1.5°C. It explores how companies can harness technology-driven innovation and sustainable design to facilitate this transition. Drawing on Raz Godelnik's Business-Driven 1.5°C Lifestyles Framework (BD1.5LF), participants will work on industry-specific scenarios to tackle real-world challenges, with a focus on the Innovation and Sustainable Design opportunity area. The session will emphasize the importance of balancing radical thinking with innovation and demonstrate how businesses can redesign their approach to climate action. By harnessing technological innovation through a designerly approach, companies can support the shift to 1.5°C lifestyles, which, in turn, will advance their efforts to meet climate targets.


Treasures & Baggage: A New Framework for Navigating Change

Dr. Param Srikantia is a professor of the management and leadership department in the Baldwin Wallace Carmel Boyer School of Business. A TEDx presenter and a keynote speaker, he has embarked on public seminars with a focus on the transformation of personal and organizational consciousness that have now grown to a contagious level of popularity reaching several hundred thousand attendees across the world. The seminars are a unique blend of humor, storytelling, pantomimes, mindfulness and applied behavioral science insights woven together in a unique genre at the intersection of education and entertainment.

Srikantia has authored over 35 scholarly papers in management, published and presented at conferences in the US, Europe, Asia, Africa and South America. He has worked in leadership positions in six global conglomerates including the World Bank Group, Arthur Andersen, the Unilever Group, the American Cyanamid Company, Lederle Laboratories and the Tata Group of Companies, in addition

to projects funded by the National Science Foundation (NSF) and USAID. He has taught as lead faculty at the Weatherhead School of Management at Case Western Reserve University, as visiting faculty at the Schar School of Government and Policy at George Mason University, and at the business programs at the University of Iowa, The FAE Business School in Brazil, the Jamnalal Bajaj Institute of Management Studies and the S.P Jain Institute of Management & Research in India.

He was invited by the Institute for Management Studies (IMS), an international training organization that features "cutting edge" thinkers to offer seminars to their membership base of companies in the United States, Canada and Europe.
